In pursuance to C.O, ND Lr.No.400-61/2004-Pers-I, Dt18/01/2007, the Chief General Manager Telecom, A.P. Circle Hyderabad, is pleased to Upgrade the pay scale of the **102** (One hundred and two) Executives who are in the pay scale of 20,600-46,500 to the pay scale of 24900-50500 (E2-E3) as Second Upgradation of Pay scale, working in **Hyderabad Telecom District**, listed in the Annexure and with effect from the dates shown as against each.

Consequent to Upgradation of IDA pay scale, there will be **NO CHANGE IN SUBSTANTIVE STATUS**, designation, duties and responsibilities of the Executive unless any change is ordered in any specific context.

Since Time Bound Upgradation of IDA Pay scale of any Executive under the policy is personal to the Executive concerned, no claim what so ever can be made by comparison on grounds of seniority, class, community, cadre, stream etc., Further, no claim will arise on account of any other provisions of FRSR in the context of pay scales, pay fixation, substantive status etc.,

Before effecting the 2<sup>nd</sup> upgradation, the date of effect of 1<sup>st</sup> Upgradation should be verified with reference to the Service Book of the Executive concerned. It should also be ensured;

1) that the officer is in the same pay scale for 5 years prior to the date of effect of 2<sup>nd</sup> upgradation. IDS Scale granted to any Executive by virtue of any local officiating arrangement will not count for the purpose of IDA pay scale Upgradation.

2) there is no disciplinary/vigilance case pending or contemplated against the officer and the officer is not undergoing any currency of penalty on the date of effect of upgradation.

The Pay fixation under 2<sup>nd</sup> Time bound Upgradation shall be allowed as per item No. 8 of CO, ND Lr. No. 1-11/2009-PAT (BSNL) dated 31-3-2009

Every Executive whose pay is upgraded to the next higher IDS pay scale will have to compulsorily undergo online training for being eligible for drawl of SECOND increment in the upgraded scale and the training is to be completed with in a period of two years from the date of the 2<sup>nd</sup> upgradation order to the higher scale. Details of online training can be had from the site [www.training.bsnl.co.in](http://www.training.bsnl.co.in). For course materials, it can be downloaded by login in to Corporate office intranet site→digital library→induction and upgradation materials. **However, the Executives who have already retired / are retiring within a period of two years from the date of issuance of time bound IDA pay scale up-gradation order, are exempted from such training.**
