The Long standing Transfers and Postings in respect of the SDEs [Telecom] are hereby ordered in the interest of service with immediate effect as mentioned in the Annexure.

The SSA Heads are requested to relieve the Officers immediately without waiting for the substitutes, since this office has posted to the extent of SDEs with respect to Circle average working in the cadre of SDE.

The leave, if any requested by the Officers, under transfer, should not be allowed. If the officers desires leave, they can apply for it to the Competent Authority only after joining the new posting and the Competent Authority at the new place of posting will only sanction leave, if considered justified, in the normal course.


In case of any officers released by has not joined his new assignment and occupying departmental accommodation, having service Telephone (Fixed or Mobile) should be allowed only for a period for which he/she is eligible and thereafter all such facilities should be disconnected or charges be levied as per departmental norms.

In case, the officers does not report at posted SSA/Station by 1st April, 2018, his/her pay and allowances will not be drawn from the working SSA and same shall be drawn from the posted SSAs only after joining of the Officers.

The SDEs who are looking after to the duties of AGMs/DEs [T] should be revered to the substantive cadre before their relief.

Necessary charge reports may be forwarded to all concerned.


